NOTICE OF RACE

Friday 12 February 2021 to Friday 19 March 2021

SPONSORED BY BOMBORA ON THE RIVER

1. ORGANISING AUTHORITY:

The organising authority is the Goolwa Regatta Yacht Club Inc (GRYC).

2. WHERE:

The races in this Series will be held in the waters adjacent to GRYC between Aggies Creek and Laffin Point.

3. RACE SCHEDULE

This Series will be a 6 race Series, with 1 drop, as follows:

Race 1	Friday 12 February 2021	18.00 hrs
Race 2	Friday 19 February 2021	18.00 hrs
Race 3	Friday 26 February 2021	18.00 hrs
Race 4	Friday 5 March 2021	18.00 hrs
Race 5	Friday 12 March 2021	18.00 hrs
Race 6	Friday 19 March 2021	18.00 hrs

The presentation of the Series Prizes will be made after Race 6.

4. ELIGIBILITY AND ENTRY

Each race in the Series is open to all yachts that meet the requirements for the following Divisions:

Division 2: Trailable yachts without spinnakers

Division 3: Trailable yachts with spinnakers

Visiting yachts are welcome to compete and are eligible for individual race prizes but are not eligible for the Series prizes as Twilight Series 3 is not an Open Series.

To enter a race in the Series the Person in Charge of a yacht must complete a Race Entry Form for the race and pay the fee of \$15 for GRYC Members and \$20 for Visitors prior to the Race Briefing. Payments can be made by cash or credit card at GRYC.

5. SAILING INSTRUCTIONS:

The 2020-2021 Sailing Instructions will apply to each race in this Series. They are located under the "Racing" tab on the GRYC website.

6. CATEGORY OF RACE AND SAFETY:

The race will be conducted as a Category 7 race under Australian Sailing Special Regulations Part 1.

In addition to complying with the Category 7 requirements, all yachts must comply with the safety requirements listed in the 2020-2021 GRYC Sailing Instructions.

Sailors are reminded that every yacht is to render assistance to any yacht that needs it or who has requested assistance.

7. COURSE AND BRIEFING:

There will be a briefing at 1730 hrs at GRYC and the first warning signal will be at 1800 hrs.

The course for each race will be advised at the briefing.

8. PRIZES:

Subject to this Notice of Race and the 2020-2021 Sailing Instructions, the prizes for:

- 8.1 each race in Division 2, 1st and 2nd on GRYC Mixed Fleet Ratings and 1st and 2nd on Performance Handicap;
- 8.2 each race in Division 3, on Mixed Fleet Ratings, 1st Sportsboat (MFR .800 and above), 1st Restricted 21 and 1st Trailable Yacht (MFR less than .800); and
- 8.3 the Series in each Division, 1st and 2nd on GRYC Mixed Fleet Ratings and 1st and 2nd on Performance Handicap.

9. INSURANCE:

Each participating yacht shall be insured with valid third party liability insurance with a minimum cover of \$10,000,000 per incident or the equivalent.

10. DISCLAIMER

Competitors participate in the Series entirely at their own risk. See Rule 4 Decision to Race. The Organising Authority will not be liable to any person on any basis whatsoever in connection with personal injury or death or in connection with any property damage sustained or caused in conjunction with or prior to, during or after any race in the Series.
