1. ORGANISING AUTHORITY

The Organising Authority will be the Goolwa Regatta Yacht Club (GRYC).

2. RULES

Each race in the Series will be governed by the Rules as defined in the current Racing Rules of Sailing (RRS) except as altered by the GRYC standard Sailing Instructions.

3. ELIGIBILITY AND ENTRY

Each race in the Series is open to all boats which fit into the following Divisions:

Division 2 Trailable Yachts without spinnakers

Division 3 Trailable Yachts with spinnakers

Division 4 Monohull Off The Beach Yachts

PLEASE NOTE: Once a boat has entered in a division in a Series it must remain in that division for that Series.

Boats shall enter a race in the Series by completing the individual race Entry Form and paying the appropriate fee; \$15 for GRYC members and \$20 for visitors. A Race Briefing for each race will be conducted at the GRYC 30 minutes before the first warning signal. The starting order will be announced at the briefing.

5. SAILING INSTRUCTIONS

The 2019-2020 GRYC Sailing Instructions (effective 1 Oct, 2019) will apply to each race in this Series and they can be found on the GRYC website under the "Racing Tab".

6. COURSES

A course description will be made available at the sign on desk at GRYC prior to each race briefing.

7. SAFETY

Each race in the Series will be conducted as a Category 7 race under Australian Sailing Special Regulations Part 1.

8. DISCLAIMER

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

9. INSURANCE

Each participating boat shall be insured with valid third party liability insurance with a minimum cover of \$10 000 000 (ten million) per incident or the equivalent.
