Committee Positions

The GRYC Constitution provides for the following positions on the General Committee:

- Commodore
- Vice Commodore
- Rear Commodore
- Secretary
- Treasurer
- General Committee Members (five positions)

Part IV of the Club Constitution outlines the Officers and Duties.

Portfolios are allocated for all positions including General Committee Members.

Whilst some sitting General Committee members may seek re-election this does not preclude any eligible member from nominating for any position.

Eligibility of Nominees

- 1. A person may not become or remain as a member of the General Committee unless they are a Life, Veteran or Senior member of GRYC
- 2. A person is ineligible to be elected, re-elected or to act as a member of the General Committee if that person;
 - (a) Is an insolvent under administration within the meaning of the Associations Incorporation Act 1985 as amended, or,
 - (b) has, within the previous five years, been convicted, either within or outside South Australia, on an indictment of an offence involving fraud or dishonesty and punishable upon conviction by imprisonment for a period of not less than three months.
- 3. Any person who has held the position of Commodore during four consecutive complete terms of office is ineligible to be elected, re-elected or appointed to any position as a Flag Officer for a period of four years from that day on which that person completed his/her last term of office as Commodore.

Nomination Forms

- 1. Proposers and Seconders must be Life, Veteran or Senior Members of GRYC
- 2. The GRYC Constitution provides that nomination forms must be delivered to the Secretary before 1700 hours on the fourth Friday prior to the Annual General Meeting. For the purpose of the 2017 AGM they must be delivered to the Secretary before 1700 hours on Friday 26th May, 2017.

General

Any nominee may withdraw his/her nomination in writing at any time before the Annual General Meeting. In the event of an election, nominees will be required to provide a personal statement.
